3. Skagen Designs, Ltd. was merged into Fossil, Inc. effective July 1, 2012.




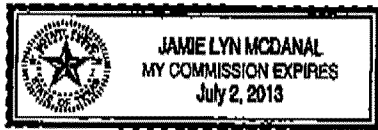
