## ASSIGNMENT

**WHEREAS**, the Superior Court of Arizona entered an Order Granting Relief Re: Enforcement of Settlement on September 14, 2012, in case number CV2010-050768 directing the Defendants Farmasea Health, LLC and Scott Kennedy to immediately re-transfer the Trademark Collateral described in Exhibits A and B from FarmaSea, Inc. to Farmasea Health, LLC and to Scott Kennedy in compliance with the Settlement Agreement among the parties;

**WHEREAS**, the Order further provided that if no Notice of Compliance was filed by Noon on September 28, 2012, then Plaintiff may provide the Clerk of the Court with the papers necessary to accomplish the re-transfer of the Trademark Collateral in accordance with this Order, and no such Notice of Compliance was filed;

**WHEREAS**, the Order further authorized and directed the Clerk to execute the re-transfer documents on behalf of the Defendants pursuant to ARCP 70 without further notice to any party and to deliver the executed documents of re-transfer to counsel for Plaintiff; and

**WHEREAS**, the undersigned is a duly empowered Clerk of the Maricopa County Superior Court of Arizona authorized to act on behalf of FarmaSea, Inc. to effect the re-transfer of the Trademark Collateral,

**NOW, THEREFORE**, the undersigned hereby:

1. Orders and effects re-transfer from FarmaSea, Inc. to Farmasea Health, LLC all right, title, and interest in and to the Trademark Collateral listed in Exhibit A, together with the good will of the business with which such Trademark Collateral is used, or that part of the good will connected with the use of, and symbolized by, such Trademark Collateral, and any related registrations, applications, or rights, including any registration applications or like documents or rights, and any rights of priority under the law and any international agreements to which the United States adheres; and
2. Orders and effects re-transfer from FarmaSea, Inc. to Scott Kennedy all right, title, and interest in and to the Trademark Collateral listed in Exhibit B, together with the good will of the business with which such Trademark Collateral is used, or that part of the good will connected with the use of, and symbolized by, such Trademark Collateral, and any related registrations, applications, or rights, including any registration applications or like documents or rights, and any rights of priority under the law and any international agreements to which the United States adheres.


