

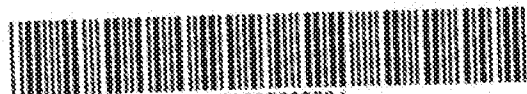
1. The name of the entity is: Envirodine Studios, Inc. (the "Corporation").


