CONFIRMATION OF TRADEMARK ASSIGNMENT

This Confirmation of Trademark Assignment ("**Assignment**") is entered into by and between Tandberg Telecom AS a company organized and existing under the laws of Norway ("Tandberg Telecom"), and Cisco Systems International S.Á.R.L., a Swiss limited liability company, and a wholly-owned indirect subsidiary of Cisco Systems, Inc., a California corporation ("CSIS").

WHEREAS, pursuant to a prior Agreement for Purchase and Sale of Assets effective July 31, 2011 at 11:00 a.m. Pacific Daylight Time between Tandberg Telecom and CSIS (the "**Asset Purchase Agreement**"), certain intellectual property rights, including without limitation all rights, title and interest in and to the Tandberg Telecom Marks (as defined below), were assigned previously to CSIS.

NOW, THEREFORE, Tandberg Telecom and CSIS agree as follows and confirm that:


"**Tandberg Telecom Marks**" means all of Tandberg Telecom's trademarks, service marks, trade names, trade dress, logos, designs and slogans, in word mark, stylized and/or design formats, including without limitation Tandberg Telecom's trademark registrations and applications (except for Tandberg Telecom's Intent-to-Use U.S. applications for which Amendments to Allege Use or Statements of Use have not yet been filed with the U.S. Patent and Trademark Office) and any and all of Tandberg Telecom's common law rights in the aforementioned items, together with all goodwill associated with and symbolized by the aforementioned items, including without limitation the marks identified in Schedule 1 attached hereto and all of the goodwill associated with and symbolized by such marks.

Tandberg Telecom has assigned and transferred, and CSIS has received and accepted, all of Tandberg Telecom's rights, title and interest in the United States in and to the Tandberg Telecom Marks and all the rights, claims and privileges pertaining to the Tandberg Telecom Marks, including without limitation: the registrations and applications pertaining thereto (except for Tandberg Telecom's Intent-to-Use U.S. applications for which Amendments to Allege Use or Statements of Use have not yet been filed with the U.S. Patent and Trademark Office), together with all of the goodwill of the business associated with and symbolized by the Tandberg Telecom Marks; and the right to sue and recover damages for past, present and future infringements thereof and to stand in the place of Tandberg Telecom in all matters related thereto.


Tandberg Telecom hereby authorizes and requests the United States Commissioner of Patents and Trademarks to implement this Assignment.
