ASSIGNMENT OF SECURITY INTEREST IN TRADEMARKS

Reference is made to (a) the Second Lien Trademark Security Agreement dated as of April 7, 2008 (the "2008 Trademark Security Agreement"), between Merrill Communications LLC, a Delaware limited liability company as successor by merger to Legal Computer Solutions, Inc. ("Merrill") and Bank of America, N.A. ("BANA"), as administrative agent (together with its successor(s) thereto in such capacity, the "Collateral Agent") for each of the Secured Parties (as defined therein) (the "Assignor") and (b) the Second Lien Trademark Security Agreement, dated as of November 29, 2006 (the "2006 Trademark Security Agreement"; the 2008 Trademark Security Agreement and 2006 Trademark Security Agreement, collectively, the "Trademark Security Agreements"), between Merrill Communications LLC, a Delaware limited liability company (including as successor by merger to Merrill Fine Arts Engraving, Inc. ("Fine Arts"), a Minnesota corporation, the "Company"), Merrill Brink International Corporation, a Minnesota corporation ("Brink"), and WordWave, Inc., a Delaware corporation ("WordWave"; Merrill, the Company, Brink, Fine Arts and WordWave, collectively, the "Grantors", and each a "Grantor"), and Assignor. Capitalized terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Trademark Security Agreements.

Pursuant to the Trademark Security Agreements Grantors granted the Collateral Agent a security interest in, among other things, the Trademarks including, without limitation, the Trademarks listed on Schedule I attached hereto; and

The Assignor recorded the 2008 Trademark Security Agreement with the United States Patent and Trademark Office on April 24, 2008 at Reel 3765 Frame 0422 and the 2006 Trademark Security Agreement with the United States Patent and Trademark Office on December 18, 2006, at Reel 3446, Frame 0336, at Reel 3446, Frame 0326, at Reel 3446, Frame 0346, and at Reel 3446, Frame 0356.

The Assignor has been succeeded by Gleacher Products Corp., as Administrative Agent and Collateral Agent under the Second Lien Credit Agreement (the "Assignee").

AGREEMENT

The Assignor, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, hereby assigns to the Assignee all of its right, title and interest in the security interest in the Collateral granted under the Trademark Security Agreements, including, without limitation, security interests in the Grantors' right, title and interest in and to the Trademarks set forth on Schedule I hereto (collectively, the "Assigned Trademark Security Interests"). This assignment is made without recourse, representations or warranties of any kind.
