RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this "Release") is made as of October 1, 2012 ("Effective Date") by Bank of America, N.A., a national banking association (the "Secured Party"), as administrative agent, in favor of New Breed, Inc., a North Carolina corporation ("New Borrower").

WHEREAS, New Borrower, the Secured Party and certain other persons are parties to that certain Pledge and Security Agreement, dated July 1, 2010 (the "Security Agreement") pursuant to which New Borrower granted the Secured Party, as administrative agent, a security interest in certain assets of New Borrower;

WHEREAS, in connection with the Security Agreement, New Borrower and the Secured Party entered into a Trademark Security Agreement, dated July 1, 2010 (the "Trademark Security Agreement"), pursuant to which New Borrower granted the Secured Party, as administrative agent, a security interest in the Trademark Collateral (as defined therein), including the trademark registrations set forth on Schedule A hereto (collectively, the "Trademarks");

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on July 12, 2010, at Reel/Frame 4240/0211; and

WHEREAS, New Borrower hereby requests that Secured Party release its security interest in the Trademarks.

NOW, THEREFORE, upon release by Secured Party of its signature hereto, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party hereby (i) terminates the Trademark Security Agreement, (ii) terminates, cancels and releases any and all security interests or liens it has against the Trademarks, and (iii) re-assigns to New Borrower any right, title and interest it may have in, to and under the Trademarks (including, without limitation, the goodwill associated therewith).

The Secured Party shall, at New Borrower's expense, take all further actions, and provide to New Borrower, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by New Borrower to more fully and effectively effectuate the purposes of this Release.
