**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Release") is made as of October 10, 2012 ("Effective Date") by Wells Fargo Foothill, Inc., a Delaware limited liability company, in its capacity as agent for the Lender Group (as defined in the Security Agreement referred to below) ("Agent").

**WHEREAS**, Source Medical Solutions, Inc., ("Grantor") and Agent entered into that certain Security Agreement dated as of May 15, 2006, and that certain Supplement No. 1 to the Security Agreement dated as of February 2, 2007 (the "Security Agreement");

**WHEREAS**, pursuant to the Security Agreement, Grantor and Agent entered into that certain Trademark Security Agreement dated October 9, 2008 (the "Trademark Security Agreement") for the purpose of recording a security interest on the Trademark Collateral (as defined in the Trademark Security Agreement), including those items set forth on Schedule I hereto, with the United States Patent and Trademark Office;

**WHEREAS**, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on October 9, 2008, at Reel 003867, Frame 0674; and

**WHEREAS**, Grantor has paid all of its outstanding indebtedness to Agent.


**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby, on behalf of itself and the Lender Group, (i) terminates the Trademark Security Agreement, (ii) terminates, cancels and releases any and all liens and security interests it has against the Trademark Collateral, and (iii) re-assigns to Grantor any right, title and interest it may have in, to and under the Trademark Collateral.

This Release shall be governed by and construed in accordance with the laws of the State of New York.
