
RELEASE

In consideration of the payment of all indebtedness and amounts secured by that certain Trademark Security Agreement made as of August 18, 2003, by and between Superior Bakery, Inc., a Delaware corporation, with a principal place of business at 72 Main Street, Grosvenordale, MA 06255 (the "**Borrower**"), and Cambridge Savings Bank, a Massachusetts savings bank with a principal place of business at 1374 Massachusetts Avenue, Cambridge, MA 02138-3822 (the "**Bank**"), which Trademark Security Agreement was filed with the United States Patent and Trademark Office on August 29, 2003, and recorded in Reel 2709, Frame 0206 of the Trademark Assignment Records, the Bank hereby releases and discharges all of its right, title and interest in and to the above-described Trademark Security Agreement, including the security interest and conditional assignment created and existing thereunder on the property described in and covered thereby, and reassigns to the Borrower any right, title and interest of the Bank in and to the "Collateral" described therein, including the right to recover for past infringement of any of the Collateral and the goodwill of the goodwill of the business in connection with which the Collateral is used and which is symbolized by any of the Collateral.

Reference is made to the above-described Trademark Security Agreement and the recordation thereof for all purposes in connection herewith.

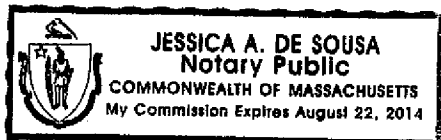
