RELEASE OF TRADEMARK SECURITY INTEREST

WHEREAS, by a Security Agreement dated April 9, 2009, Cook Sales, Inc., an Illinois corporation (the "Grantor"), granted a security interest in certain trademark rights, including the United States trademark registrations listed in Exhibit A attached hereto and as described in the Security Agreement to the bank formerly known as Southwest Bank (an M&I Bank); and
