


**RELEASE OF SECURITY INTEREST

(subsequently converted to Long John Silver's, LLC) in favor of the Lender (collectively, the "Security Agreement") and the latter recorded with the U. S. Patent and Trademark Office on December 27, 2010, at Reel 00441, Frame 0181. All obligations and duties under said Security Agreement, to the extent they relate to the Trademarks or the Registrations, are hereby released and terminated, and the Lender hereby expressly releases and discharges without limitation all claims, demands and causes of action that it may now have or might subsequently accrue to it arising out of or connected with, directly or indirectly, the aforesaid Security Agreement to the extent it relates to the Trademarks or the Registrations.

This Release shall be binding upon the Lender's legal representatives, successors and assigns.
