## ASSIGNMENT

WHEREAS Voith Paper Fabric & Roll Systems, Inc. (the Assignor), a corporation organized and existing under the laws of the state of North Carolina, and having a place of business at 3040 Black Creek Road, Wilson, North Carolina 27893, is the owner of the entire right, title and interest in and to the trademark "NIPSCAN" which is the subject of U.S. Trademark Registration No. 3,214,500, issued March 6, 2007;

WHEREAS Voith Patent GmbH (the Assignee), a corporation organized and existing under the laws of the country of the Federal Republic of Germany, having a place of business at Sankt Pöltener Strasse 43, D-89522 Heidenheim, Federal Republic of Germany, is desirous of acquiring the entire right, title and interest in and to said trademark;

NOW THEREFORE, in the consideration of good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Assignor does hereby assign, sell and transfer unto the Assignee all the right, title and interest in and to the trademark and registration together with the goodwill of the business symbolized by the trademark.

Assignor authorizes and requests the Commissioner of Patents and Trademarks to record Assignee as owner of the NIPSCAN trademark, including any renewals thereof and to issue any pertaining registration to Assignee, as assignee of the entire right, title and interest in and to the same, for the sole use and enjoyment of Assignee, its successors, assigns or other legal representatives.

Assignor shall provide Assignee, its successors and assigns or other legal representatives, reasonable cooperation and assistance at Assignee's request and at Assignee's reasonable expense (including the execution and delivery of any and all affidavits, declarations, oaths, assignments, powers of attorney or other documentation as may be reasonably required) in the preparation and prosecution of any applications covering the NIPSCAN trademark assigned herein; in the

prosecution or defense of any opposition, infringement or other proceedings that may arise in connection with any of the trademark rights assigned herein, including testifying as to any facts relating to the rights assigned herein and this Assignment; in obtaining any additional protection pertaining to the NIPSCAN trademark that Assignee may deem appropriate which may be secured under the laws now or hereafter in effect in the United States or any other country; and in the implementation or perfection of this Agreement.

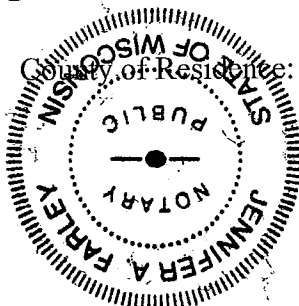
