TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT is made as of July 20, 2012 (this "<u>Assignment</u>"), by Focus Products Group, LLC, an Illinois limited liability company (the "<u>Assignee</u>"), and FPG, LLC, an Illinois limited liability company (the "<u>Assignee</u>"). Capitalized terms used but not otherwise defined herein are intended to have the meanings set forth in the Asset Purchase Agreement (as defined below).

WHEREAS, the Assignor is the owner, subject to any right, title and interest of the Agent (as defined below) in the Assigned Marks (as defined below) for the ratable benefit of the Secured Lender Parties (as defined below), of all right, title and interest in and to the trademarks and trademark registrations and applications identified on the attached Schedule A (collectively, the "Assigned Marks"), and all of the assets and goodwill of the Business to which the Assigned Marks pertain.

WHEREAS, in connection with that certain Second Amended and Restated Credit Agreement, dated as of October 16, 2009 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), by and among Bank of America, N.A., as administrative agent and collateral agent (the "Agent") for the lender parties (collectively, the "Secured Lender Parties"), the Assignor and the other Secured Lender Parties, the Agent, the Assignor and certain of the Company Parties entered into that certain Trademark Security Agreement, dated as of October 16, 2009 (the "Security Agreement"), pursuant to which the Agent, for its benefit and the ratable benefit of each Secured Lender Party, was granted a continuing security interest in all of the Company Parties' right, title and interest throughout the world, whether now or hereafter exiting or acquired, in and to the trademarks and trademark registrations and applications of the Company Parties (the "Company Marks");

WHEREAS, the Assignor understands that pursuant to the terms of that certain Asset Purchase Agreement (the "Asset Purchase Agreement"), dated as of July 20, 2012, the Agent sold, assigned, transferred, conveyed and delivered to the Assignee pursuant to a private sale in accordance with Article 9 of the Uniform Commercial Code, as adopted in the State of Illinois, all of the Company Parties' right, title, and interest in and to the Acquired Assets, including the Assigned Marks, wherever located, whether tangible or intangible, as the same shall exist on the Closing.

WHEREAS, the Assignor understands that pursuant to the terms of that certain Release of Trademark Security Agreement dated as of July 20, 2012 and entered into in connection with the Asset Purchase Agreement, the Agent released all of its security interest under the Security Agreement in and to the Company Marks and dissolved any and all of its liens and encumbrances respecting the Company Marks.

WHEREAS, in accordance with the terms of that certain Side Agreement, dated as of July 20, 2012, by and between the Company Parties and the Assignee, the Assignor desires to execute and deliver this Assignment in order to effectuate the sale, assignment, transfer, conveyance and delivery to the Assignee of all worldwide rights, title and interest in and to the Assigned Marks and all of the assets and goodwill of the Business to which the Assigned Marks pertain.

NOW, THEREFORE, FOR VALUE RECEIVED, the Assignor does hereby assign, sell and transfer to the Assignee, subject to any right, title and interest of the Agent in the Assigned Marks for the ratable benefit of the Secured Lender Parties, all of its right, title and interest in and to the Assigned Marks and all of the assets and goodwill of the Business to which the Assigned Marks pertain, together with all rights under any applicable international treaties and agreements, the same to be held and enjoyed by the Assignee for its own use and benefit and the use and benefit of its successors, assigns and legal representatives, as fully and entirely as the same would have been held and enjoyed by the Assignor, together with all rights of action accrued, accruing and to accrue under and by virtue hereof, including all right to sue or otherwise recover for past infringement and to receive all damages, payments, costs and fees associated therewith, free and clear of all liens and encumbrances. The Assignor hereby acknowledges that this Assignment, being of its entire right, title and interest in and to the Assigned Marks, carries with it the right in the Assignee to apply for and obtain from competent authorities in all countries of the world any and all Assigned Marks by attorneys and agents of the Assignee's selection and the right to procure the grant of all Assigned Marks to the Assignee in its own name as assignee of the Assignor's entire right, title and interest therein;

AND, the Assignor hereby further agrees for itself and its executors and administrators to execute upon request any other lawful documents and likewise to perform any other lawful acts which may be deemed necessary to secure fully the Assigned Marks to the Assignee, its successors, assigns, and legal representatives, but at its or their expense and charges;

AND, the Assignor hereby further agrees, at the Assignee's expense and charges, to provide statements or testimony in any proceeding in which the Assigned Marks may be involved;

AND, the Assignor hereby authorizes and requests the Director of the United States Patent and Trademark Office to issue any U.S. registrations which arise from any of the Assigned Marks to the Assignee, its successors, assigns, or legal representatives.

The Assignor agrees to execute, and to cause any of the other Company Parties to execute, such additional documents as the Assignee deems reasonably necessary to enable the Assignee to record this Assignment in the Assignee's name in any country throughout the world.

This Assignment may be executed in any number of counterparts, all of which taken together shall constitute one and the same instrument and any of the parties hereto may execute this Assignment by signing any such counterpart.

The undertakings, covenants and agreements set forth herein shall be binding upon and inure to the benefit of the Assignee and the Assignor and their respective successors and assigns.
