TRADEMARK ASSIGNMENT [REDACTED] AGREEMENT

This Trademark Assignment [REDACTED] ("Agreement") is entered into this 15th day of July, 2012 (the "Effective Date"), by and between MeetMe, Inc., a Delaware corporation, located at 100 Union Square Drive, New Hope, PA 18938 ("MeetMe") and Tagged, Inc., a Delaware corporation, located at 840 Battery Street, Second Floor, San Francisco, CA 94111 ("Tagged") (collectively, the "Parties").

WHEREAS, Tagged applied to register MEET ME, as a wordmark consisting of "Meet" and "Me" as two separate words (the "Tagged MEET ME Name and Mark"), under United States Application Serial No. 85/588392 (the "Tagged MEET ME Application"), claiming first use in May 2008:

WHEREAS, as part of the settlement and compromise, MeetMe will acquire from Tagged and Tagged will assign and transfer to MeetMe all rights, claims and uses in Tagged's MEET ME Name and Mark as owned in the United States and any other country, including but not limited to the Tagged MEET ME Application and any uses associated with mobile applications named "Meet Me", online social networking and dating services, and online chat rooms under the name "Meet Me" as in use by Tagged at www.tagged.com (the "Site") or another website, and computer software and services related thereto (collectively, the "Rights"); and

NOW, THEREFORE, for and in full consideration of the mutual promises contained herein, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties mutually agree as follows:

1. Assignment of Rights. Tagged hereby irrevocably assigns, transfers, sells and delivers to MeetMe, its successors and assigns, all of Tagged's rights, title, and interest in and to the Rights, including all common law rights, that it has throughout the United States and worldwide, together with the goodwill of the business associated therewith and symbolized by the Tagged MEET ME Name and Mark, and together with all causes of action for the past, present and future infringement of the Rights.

2. Authority. Tagged hereby authorizes the United States Patent and Trademark Office and/or any official of any other country empowered to issue trademark registrations to record this assignment. Tagged agrees to execute and deliver to MeetMe any additional documents as MeetMe may reasonably require in order to confirm and/or perfect MeetMe's sole and absolute right and title in the Rights, including the Tagged MEET ME Application, all at MeetMe's cost and expense.

8. Rights. Tagged acknowledges that following the assignment, MeetMe is the owner of all rights, title and interests in and to the Rights and of the goodwill associated therewith. All use of the Rights by Tagged, including any goodwill in connection with the Rights, shall inure to the benefit of MeetMe. To the extent that Tagged, or its successors, assigns or sublicensee, may acquire any interest in the Rights through its use under its license, such rights shall inure to the benefit of MeetMe and Tagged hereby assigns such interest to MeetMe, together with any goodwill associated therewith.

13. Entire Agreement. This Agreement constitutes the entire understanding of the parties, and supersedes any prior agreements or communications, concerning the subject matter described herein and therein. Nothing in this Agreement shall be deemed to create any agency, joint venture, franchise or partnership between MeetMe and Tagged, and neither party shall so hold itself out. Neither party has the right to bind the other party any manner. This Agreement shall not create any rights in third parties.


14. Governing Law. This Agreement shall be interpreted and construed in accordance with the laws of the State of Delaware, without giving effect to choice of law principles. Both parties agree that all actions hereunder may be brought only in the federal or state courts located within the State of Delaware, County of New Castle, and both parties consent to the personal jurisdiction of those courts.

15. Waiver; Amendment. The failure of either party to require performance of any provision hereof shall in no manner be deemed a waiver of such breach or of any other provision hereof. This Agreement may not be amended except in a writing signed by both parties.



Each such counterpart shall be deemed to be an original instrument, and all counterparts shall be construed together and shall constitute one agreement.
