RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY INTEREST (this "Release") is given on September 28, 2012, by FORTRESS CREDIT CORP., in its capacity as Agent for the Lender Group (the "Agent"), to the Grantors listed on Schedule A (the "Grantors" and each a "Grantor").

WHEREAS, the Grantors, certain other companies and the Agent are party to (a) a Security Agreement dated as of July 13, 2011, (as amended, modified and supplemented to the date hereof, the "Security Agreement"), (b) a Trademark Security Agreement dated as of July 13, 2011 and (c) a Trademark Security Agreement dated as of March 13, 2012 (the agreements described in clauses (b) and (c) above, the "Trademark Security Agreements");

WHEREAS, pursuant to the Security Agreement and Trademark Security Agreements, the Grantors granted to the Agent, among other collateral, a continuing security interest in all of the Grantors' right, title and interest, including goodwill, in, to and under the United States trademarks listed on the attached Schedule A (the "Trademark Collateral");

WHEREAS, the Trademark Security Agreements were recorded in the United States Patent & Trademark Office on July 20, 2011 at reel/frame 4589/0304 and March 29, 2012 at reel/frame 4748/0298, respectively;

WHEREAS, the Agent wishes to release its security interest in the Trademark Collateral and retransfer and reassign to the Grantor without recourse all of the Agent's right, title and interest in, to and under the Trademark Collateral.

NOW THEREFORE, the Agent hereby releases any security interest it may have in the Trademark Collateral, and reassigns to the relevant Grantor any and all right, title and interest it may have in, to and under the Trademark Collateral without recourse.
