TRADEMARK ASSIGNMENT

WHEREAS, Fountain Industries Co., a Minnesota corporation ("Assignor"), owns the trademark applications and registrations listed in Exhibit A (the "Marks");

WHEREAS, Fountain Industries, LLC, a Delaware limited liability company ("Assignee"), is desirous of acquiring all of Assignor's right, title and interest in and to the Marks; and

WHEREAS, Assignor and Assignee have entered into that certain Asset Purchase Agreement dated May 31, 2012, pursuant to which Assignee is purchasing, among other things, certain intellectual property of Assignor, including the Marks, and has agreed to execute and deliver this Trademark Assignment, for recording with governmental authorities including, but not limited to, the U.S. Patent and Trademark Office (the "APA").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound hereby, and in all cases subject to the terms and conditions of the APA, the parties agree as follows:

1. Assignment. Assignor hereby sells, assigns and transfers to Assignee, its successors and assigns, its entire right, title and interest in and to the Marks together with that portion of Assignor's business in connection with which it has a bona fide intent to use the Marks, the goodwill of the business associated with the Marks, all rights to seek and collect damages and other relief for past and future infringements and all proceeds thereof and all other rights and proceeds associated therewith.

2. Terms of the APA. The terms of the APA, including, but not limited to, the representations, warranties, covenants, agreements and indemnities relating to the Marks are incorporated herein by this reference. The parties hereto acknowledge and agree that the representations, warranties, covenants, agreements and indemnities contained in the APA shall not be superseded hereby but shall remain in full force and effect to the full extent provided therein. In the event of any conflict or inconsistency between the terms of the APA and the terms hereof, the terms of the APA shall govern.
