TRADEMARK ASSIGNMENT

NOW, THEREFORE, in return for good and valuable consideration, the receipt of which is hereby acknowledged, said ASSIGNOR does sell, assign, transfer, convey, and set over to ASSIGNEE the entire right, title, and interest in and to aforesaid trademark THE VIBE for the products marketed under aforesaid trademark, including without limitation massage chairs and massagers in the nature of electromechanical massage mechanism for chairs, including any and all common law rights arising from ASSIGNOR's use of the trademark, and United States Trademark Registration No. 3,577,078, in the United States, together with the goodwill of the business symbolized by the mark and trademark registration, and including the right to sue for and collect for past infringement thereof; and the United States Commissioner of Patents and Trademarks is requested to issue any and all Certificates of Registration of aforesaid mark and/or trade dress to ASSIGNEE. ASSIGNOR agrees that it will execute any formal papers as requested by ASSIGNEE to effect the assignment herein, and in the event ASSIGNOR is unable to execute or otherwise refuses to execute any said documents, ASSIGNOR hereby authorizes and grants power of attorney to ASSIGNEE to execute said documents on ASSIGNOR's behalf.
