**RELEASE OF SECURITY INTEREST IN  
INTELLECTUAL PROPERTY COLLATERAL**

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL (this "Release"), dated effective as of October 26, 2012, is made by **ORIX Corporate Capital Inc.** (f/k/a ORIX Finance Corp.), a Delaware corporation ("Assignee"), with respect to the security interest granted to it by **Insight Equity A.P. X, LP** ("Assignor"), a Texas Limited Partnership, in all Patent Collateral and Trademark Collateral (each as defined below).

**W I T N E S S E T H**

WHEREAS, in that certain Trademark Security Agreement dated December 18, 2007 and that Patent Security Agreement dated December 18, 2007 and supplements made from time-to-time thereto (collectively, the "Intellectual Property Security Agreements"), Assignor granted Assignee a security interest in certain Patent Collateral and certain Trademark Collateral.

WHEREAS, Assignee has agreed to terminate the Intellectual Property Security Agreements.

NOW, THEREFORE, in consideration of the foregoing, Assignee hereby agrees as follows:

**1. Definitions**

a. "Patent Collateral" means all Assignor patents and patent applications including, without limitation, the patents and patent applications identified on Schedule I.

b. "Trademark Collateral" means all Assignor trademark registrations and registration applications including, without limitation, the trademark registrations and registration applications identified in Schedule II, together with the goodwill of the business connected with the use of the relevant trademarks.

**2. Release of Security Interest**

Assignee hereby releases, transfers and assigns, without recourse, unto Assignor, all of its security interest and lien on all of such right, title and interest in, to and under the Patent Collateral and the Trademark Collateral (collectively, the "Released Collateral").

**3. Recordation**

Assignee authorizes the recordation of this Release with the U.S. Patent and Trademark Office, the filing of Uniform Commercial Code financing termination statements and the filing or recording of any other document or instrument necessary to place on record the release of the Assignee's lien upon and security interest in the Released Collateral by Assignor or any person authorized or designated by Assignor.
