TRADEMARK ASSIGNMENT

WHEREAS, Rainmaker Advisory, LLC (“Assignor”), an Oregon limited liability company with its principal office at Suite 288, 6663 Southwest Beaverton Hillsdale Highway, Portland, Oregon 97225, United States of America, owns trademark Registration No. 4111702 (“Registration”), issued on March 13, 2012, for the mark THUNDERCLOUD (“Mark”) as used with the following services:

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which Assignor hereby acknowledges:

1. Assignor hereby irrevocably sells, grants, conveys, assigns, and sets over to Assignee, and its successors and assigns, on an exclusive basis, effective as of the Effective Date (defined below), and free and clear of all liens, claims, and encumbrances: (a) all of Assignor’s right, title, and interest, including without limitation the Registration, in and to the Mark, together with the goodwill of the business concerned in any and all goods and/or services with which Assignor uses the Mark; and (b) any and all actions and rights of action for infringement, violation, or misappropriation of the foregoing right, title, and interest in and the Mark and/or otherwise with respect to the Mark, whether arising before, on, or after the Effective Date.

2. Assignor hereby represents and warrants to Assignee, and its successors and assigns, that (a) Assignor owns all right, title, and interest in and to the Mark, including without limitation the Registration; (b) Assignor has not previously assigned or licensed to any third party any of Assignor’s right, title, and interest in and to the Mark; and (c) Assignor has the right to assign to Assignee all of the rights in the Mark and the Registration assigned hereby.
