TRADEMARK ASSIGNMENT

This trademark assignment ("Assignment") entered this 26th day of October, 2012 between Enviva, LP, a Delaware limited partnership ("Assignor") whose principal offices are located at 7200 Wisconsin Avenue, Suite 1100, Bethesda, Maryland 20814, and Enviva Holdings, LP, a Delaware limited partnership ("Assignee") whose principal offices are located at 7200 Wisconsin Avenue, Suite 1100, Bethesda, Maryland 20814.

WHEREAS, Assignor is the owner of the United States registered trademarks set forth on Exhibit A, attached hereto and made a part hereof, along with all other rights, including common law rights, related to such trademarks to the extent such rights exist (collectively, the "Marks");

WHEREAS, Assignor desires to assign to Assignee, and Assignee desires to acquire, all of Assignor's rights, title and interest in and to the Marks together with the goodwill of the business associated with the use of the Marks, along with the right to recover damages and profits for any past, present and future infringements thereof.

NOW THEREFORE, in consideration of the mutual covenants contained herein, the above recitals which are hereby incorporated into this Agreement, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. **Assignment.** Assignor hereby assigns, transfers and conveys to Assignee all rights, title and interest that Assignor may have in and to the Marks, together with the goodwill of the business associated with the use of, and which is symbolized by, the Marks, along with the Assignor's right to recover for damages and profits for any past, present and future infringements of the Marks.
2. **Binding Effect.** This Assignment shall be binding upon the parties, and their successors and/or assigns, as the case may be.
3. **Recordation.** Assignee shall have the right to record freely this Assignment, as it deems appropriate, to give notice of its assigned rights contained in this Assignment including, without limitation, recording this Assignment with the United States Patent and Trademark Office.
4. **Counterparts.** This Assignment may be executed in any number of counterparts and by different parties to this Assignment, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same Assignment.


