**RELEASE OF SECURITY INTEREST
IN UNITED STATES TRADEMARKS**

THIS RELEASE OF SECURITY INTEREST IN UNITED STATES TRADEMARKS (the "Release") is made effective as of October 30, 2012 by and from BANK OF AMERICA, N.A., as Collateral Agent under the below-described Master Security Agreement (the "Grantor"), to and in favor of BLOOMBERG FINANCE ONE L.P., a Delaware limited partnership (in such capacity, the "Grantee").

WHEREAS, BLOOMBERG FINANCE L.P., a Delaware limited partnership (the "Issuer"), is party to that certain Bloomberg Finance L.P. Private Note Purchase Agreement, dated as of November 14, 2007 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the "Note Purchase Agreement"), among the Issuer, the Guarantors party thereto, the Conduit Purchasers from time to time party thereto, the Committed Purchasers from time to time party thereto, the Managing Agents from time to time party thereto and Bank of America, N.A., as Administrative Agent (in such capacity, the "Administrative Agent");

WHEREAS, the Grantee, certain affiliates thereof, the Administrative Agent and the Grantor entered into that certain Master Security Agreement, dated as of November 14, 2007 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the "Master Security Agreement");

WHEREAS, the Grantee owns the trademarks (the "Trademarks") listed on Exhibit A attached hereto, which Trademarks are pending or registered with the United States Patent and Trademark Office;

WHEREAS, a Confirmatory Grant of Security Interest in United States Trademarks was granted by the Grantee in conjunction with the security interest granted to Grantor (on behalf of and for the benefit of the Issuer) under the Master Security Agreement and recorded with the United States Patent and Trademark Office; and

WHEREAS, the Grantee has satisfied and fulfilled all of its obligations to release the Grantor's security interest in the Trademarks, and the parties seek to make record of the Grantor's release to the Grantee of any and all of its security interest in the Trademark Collateral.

NOW, THEREFORE, in consideration of the mutual covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, it is hereby agreed that:

1. Definitions. All capitalized terms not defined herein shall have the respective meaning given to them in the Master Security Agreement or incorporated therein by reference.

2. The Release. The Grantor hereby terminates, releases and discharges any security interest in the Trademarks, and assigns, transfers, and conveys to the Grantee any and all right, title or interest Grantor may have in, or to, the Trademarks without recourse to Grantor, including (1) all of the Grantee's right, title and interest in and to the Trademarks, together with (2) all proceeds and products of the Trademarks, (3) the goodwill associated with such Trademarks, and (4) all causes of action arising prior to or after the date hereof for infringement of the Trademarks or unfair competition regarding the same.

3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of New York.

4. Counterparts. This Release may be signed in counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.

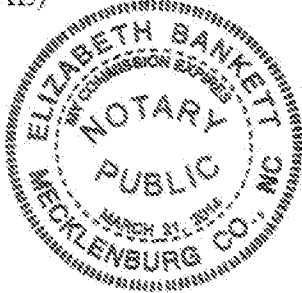




