**TERMINATION AND RELEASE OF SECURITY INTEREST IN
UNITED STATES TRADEMARKS**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN U.S. TRADEMARKS (the "**Trademark Termination and Release**") dated as of November 1, 2012, from BANK OF AMERICA, N.A., in its capacity as administrative agent (the "**Administrative Agent**") pursuant to a Security Agreement (the "**Security Agreement**") dated as of January 6, 2011 among HealthCare Partners, LLC ("**HCP**"), JSA Holdings, Inc., JSA HealthCare Corporation, and the Subsidiaries of HCP party thereto (each a "**Grantor**" and collectively, the "**Grantors**"), and the Administrative Agent.

WITNESSETH:

WHEREAS, pursuant to the Security Agreement a security interest (the "**Security Interest**") was granted by the Grantors to the Administrative Agent in certain collateral, including the Trademark Collateral (as hereinafter defined); and

WHEREAS, a Notice of Security Interest in Trademarks was recorded in the Trademark Division of the United States Patent and Trademark Office on January 11, 2011 at Reel 004450, Frame 0896, and (2) at Reel 00450, Frame 0953;

WHEREAS, the Administrative Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby agrees as follows:

1. Definitions. The term "**Trademark Collateral**", as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the Trademarks (as described in the Security Agreement), including, without limitation, those items listed on Schedule I hereto.

2. Release of Security Interest. The Administrative Agent hereby terminates, releases and discharges its Security Interest in the Trademark Collateral without representation, warranty or recourse of any kind or nature.

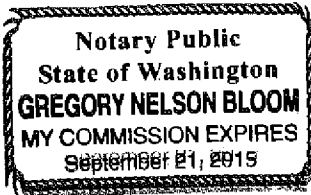
