TRADEMARK ASSIGNMENT

THIS ASSIGNMENT is effective the 1st day of November 2012 by and between Twiggy & Co. Limited, a private limited company organized under the laws of the United Kingdom, having a principal place of business at 7 Sheridan Court, 55 Barkston Gardens, London SW50ET, U.K. (the "Assignor") and Twiggy International Limited, a private limited company organized under the laws of the United Kingdom, having a principal place of business at 7 Sheridan Court, 55 Barkston Gardens, London SW50ET, U.K. (the "Assignee").

WHEREAS, Assignor has adopted and used the mark TWIGGY in connection with skin care, creams and lotions; perfumes; perfume water; cosmetics, namely, lipstick, mascara, eyeliner, eye shadow, rouge, facial powder and skin foundations, facial cleansers, astringents for cosmetic purposes; facial skin moisturizer, eye cream, facial skin cream, exfoliating body and face scrubs, anti-aging skin creams and lotions, and facial mask preparations, lotions and creams; aromatherapy preparations, namely, body oils and lotions for massage, bath oils, lotions and gels, aromatherapy scented oils, including essential oils for use in the manufacture of scented products and kits consisting essentially of such products; creams and lotions for cellulite reduction; skin moisturizers; hair care preparations; toiletries, namely, toilet water; essential oils for personal use and for use as ingredients in the manufacture of cosmetic preparations; toothpaste; tooth gels; and personal deodorants in the United States, and it is the owner of U.S. Reg. No. 2,757,883 for said mark for said products;

WHEREAS, Assignor has adopted and used the mark TWIGGY LONDON in connection with sunglasses and cases therefor; eyeglasses and cases therefor; watches; jewelry; bags, namely, totebags and handbags; leather pouches; wallets; purses; luggage; clothing namely, pants, shirts, blouses, t-shirts, tunics, jeans, blazers, jackets, dresses, shoes, and scarves; footwear; headwear in the United States, and it is the owner of U.S. Reg. No. 4,115,443 for said mark for said products;

WHEREAS, the aforementioned TWIGGY mark and TWIGGY LONDON mark shall be collectively referenced herein as the "TWIGGY Marks";

WHEREAS, Assignor wishes to assign, grant, and deliver exclusively unto Assignee all of its United States right, title, and interest of every kind and nature whatsoever in and to the TWIGGY Marks, the registrations therefor, and the goodwill relating thereto, and all right of action and claims for past infringement thereof; and,

WHEREAS, Assignee desires to acquire all of Assignor's United States rights in and to the TWIGGY Marks as set forth above.

NOW, THEREFORE, for ten dollars (\$10) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns all United States right, title, and interest in and to the TWIGGY Marks, together with the registrations

therefor, all of the goodwill relating thereto, and all rights of actions and claims for past infringement thereof.
