TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of October 31, 2012 (“Release”), is made by **JPMORGAN CHASE BANK, NATIONAL ASSOCIATION**, as Administrative Agent (including as successor administrative agent to **FIRST UNION NATIONAL BANK**) (“Administrative Agent”), in favor of **WHITEWAVE SERVICES, INC.**, a Delaware corporation (including as successor in interest to **WHITEWAVE FOODS COMPANY**, as successor by merger to **CREAMISER PRODUCTS CORPORATION** and including as successor by merger to **WHITEWAVE SERVICES, LLC**, as successor by merger to **MORNINGSTAR SERVICES INC.**) (“Borrower”).

WHEREAS, pursuant to that certain Amended and Restated Pledge and Security Agreement dated as of April 2, 2007 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the “Security Agreement”) by and among the Borrower, Administrative Agent, and others party thereto, and the Supplemental Grant of Security Interest in United States Trademarks dated as April 30, 2009 (“2009 WWS Trademark Security Agreement”), the Confirmatory Grant of Security Interest in United States Trademarks dated as February 28, 2009 (“2009 CPC Trademark Security Agreement”), the Confirmatory Grant of Security Interest in United States Trademarks dated as April 2, 2007 (“2007 WWS Trademark Security Agreement”), the Confirmatory Grant of Security Interest in United States Trademarks dated as April 2, 2007 (“2007 WWFC Trademark Security Agreement”), the Notice of Grant of Security Interest in Trademarks dated as December 31, 2001 (“2001A Trademark Security Agreement”), the Notice of Grant of Security Interest in Trademarks dated as December 21, 2001 (“2001B Trademark Security Agreement”), the Notice of Grant of Security Interest in Trademarks dated as December 21, 2001 (“2001C Trademark Security Agreement”), and the Notice of Substitution of Administrative Agent in Trademarks dated as April 2, 2007 (“Trademark Substitution Notice”, the foregoing collectively the “Trademark Security Agreements”), each by and among the Borrower and Administrative Agent, Borrower granted to the Administrative Agent, for the benefit of itself and as Administrative Agent for the Lenders, a security interest in all of Borrower’s right, title and interest in and to the Trademarks, proceeds and products of the Trademarks, the goodwill associated with such Trademarks, and all causes of action for infringement of the Trademarks or unfair competition regarding the same (“Trademark Collateral”);

WHEREAS, the 2009 WWS Trademark Security Agreement was recorded at the United States Patent and Trademark Office (“USPTO”) on August 20, 2009 at Reel 4049 Frame 0699;

WHEREAS, the 2009 CPC Trademark Security Agreement was recorded at the USPTO on April 6, 2009 at Reel 3965 Frame 0205;

WHEREAS, the 2007 WWS Trademark Security Agreement was recorded at the USPTO on April 4, 2007 at Reel 3515 Frame 0399;

WHEREAS, the 2007 WWFC Trademark Security Agreement was recorded at the USPTO on April 4, 2007 at Reel 3515 Frame 0333;

WHEREAS, the 2001A Trademark Security Agreement was recorded at the USPTO on July 25, 2003 at Reel 2689 Frame 0924;

WHEREAS, the 2001B Trademark Security Agreement was recorded at the USPTO on September 12, 2002 at Reel 2575 Frame 0326;

WHEREAS, the 2001C Trademark Security Agreement was recorded at the USPTO on September 11, 2002 at Reel 2582 Frame 0026; and

WHEREAS, the Trademark Substitution Notice was recorded at the USPTO on April 4, 2007 at Reel 3515 Frame 0320.

NOW THEREFORE, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Administrative Agent, on behalf of itself and as Administrative Agent for the Lenders, and Borrower agree as follows:

SECTION 1. Defined Terms. Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Security Agreement or Trademark Security Agreements.

SECTION 2. Termination and Release. Administrative Agent, on behalf of itself and as Administrative Agent for the Lenders, hereby:

(a) terminates the Trademark Security Agreements, and any other agreement under which Borrower has granted a collateral mortgage, pledge, hypothecation, grant, assignment, lien, or security interest in, to, and under the Trademark Collateral;

(b) terminates, cancels, forever discharges, and releases the mortgage, pledge, and hypothecation and lien on and security interest in and to the right, title, and interest in, to, and under the Trademark Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto; and

(c) authorizes the recordation of this Release with the USPTO at Borrower's expense.


SECTION 3. Further Assurances. Administrative Agent, at Borrower's expense, hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the security interest release contemplated herein. To the extent that any other filings with any other governmental authority have been made with respect to any of the Trademark Collateral, Administrative Agent will, at Borrower's expense, execute and deliver a reasonable release or other instrument that will terminate any such filing and/or release any interests conveyed therein.
