DECLARATION OF MICHAEL MCGOVERN

Pursuant to 37 C.F.R § 2.20, I, Michael McGovern, declare as follows:

1. My name is Michael McGovern. I am over the age of 18 years, of sound mind and I am fully qualified and competent to make this Declaration. I have personal knowledge of all facts stated herein and they are true and correct.
2. I am the chief Executive Officer of Array Holdings, Inc. and I have served in this capacity from 2011 to the present.
3. On November 4, 2005, Array Holdings, Inc. became the successor in interest to Array Products, LLC dating from a *de facto* merger.
4. Due to the merger, Array Holdings, Inc. purchased substantially all of the assets of Array Products, assumed the liabilities of Array Products, LLC and continued the business operations of Array Products, LLC, such there was functionally no change in the operation of the business.

5. Array Holdings, Inc., through purchasing substantially all of the assets of Array Products, LLC, became the owner of the United States Registered Trademark ACCUSEAL®, Reg. No.: 3,169,693.
6. ACCUSEAL® is still used in commerce and is currently being used for control valves for regulating the flow of gases and liquids. Further the mark has been continuously used for the same goods since its registration date of November 7, 2006.
7. ACCUSEAL® has never been the subject of a litigation dispute.
