**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**


WHEREAS, WYNIT Distribution, LLC, a New York limited liability company (the “Company”) entered into a Collateral Assignment of Security Interest in Trademarks and Licenses, dated as of May 2, 2011 (as from time to time amended, modified or supplemented, the “Trademark Security Agreement”) among the Company and KeyBank National Association, as Administrative Agent, pursuant to which the Company granted a security interest (the “Security Interest”) in all of the Company’s right, title and interest in and to the trademarks of the Company (the “Trademark Collateral”), including without limitation the trademark and trademark applications set forth on the attached Schedule A, all to the extent set forth in the Trademark Security Agreement; and

WHEREAS, all of the secured obligations have been fully paid and satisfied and the Administrative Agent desires to release the Security Interest.

NOW THEREFORE, in consideration of the foregoing and intending to be legally bound, the Administrative Agent hereby releases the Security Interest in the Trademark Collateral, and hereby, (i) waives and relinquishes all its rights, powers, privileges and remedies under the Trademark Security Agreement, (ii) sells, assigns, conveys, transfers and sets over to the Company any right, title or interest that the Administrative Agent may have acquired and re-vests in the Company the full unencumbered title to the Trademark Collateral and the goodwill associated therewith, and (iii) releases the Company from all covenants, obligations, liabilities and warranties under the Trademark Security Agreement.
