ASSIGNMENT OF TRADEMARKS

This TRADEMARK ASSIGNMENT (this "Assignment"), dated as of the 31st day of December, 2009 (the "Effective Date"), is between Nielsen Business Media, Inc., a Delaware corporation ("Assignor") and e5 Global Media, LLC, a Delaware limited liability company ("Assignee").

WITNESSETH:

WHEREAS, Assignor is the owner of all right, title and interest in and to the trademarks described on Schedule A attached hereto (the "Trademarks"); and

WHEREAS, for good and valuable consideration and pursuant to a certain purchase agreement, dated December 7, 2009, by and among Assignor, Assignee and other parties (the "Purchase Agreement"), and upon the terms and conditions set forth below, Assignor desires to assign all of its rights, title and interest with respect to the Trademarks to Assignee and Assignee desires to accept such assignment and assume all rights and obligations of Assignor associated with the Trademarks.

NOW, THEREFORE, in consideration of the transactions contemplated by the Purchase Agreement and this Assignment and of other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

1. Assignment. Assignor hereby assigns and transfers unto Assignee, its successors, heirs and assigns all right, title and interest in and to the Trademarks and the goodwill of the business with which the Trademarks are used, including without limitation, the right to any registrations thereof, the right to prosecute any applications therefor, the right to have any registrations issue in the name of the Assignee, the right to apply for and obtain any renewal of any registrations thereof, the right to any priorities based on the filing of the aforesaid applications, the right to sue for past and future infringement.

2. Further Assurances. At the reasonable request of either party and without further consideration, the other party shall execute and deliver such other instruments of assignment and assumption and take such other actions as may be necessary to effect the intent of this Agreement.

3. Covenants and Representations. The covenants, agreements, representations and warranties made by Parent (as defined in the Purchase Agreement) or Assignee, as applicable, in the Purchase Agreement with respect to the Trademarks are hereby incorporated herein by this reference and shall inure to the benefit of, and be binding upon, the parties hereto, and their respective successors and permitted assigns, subject to the limitations, terms and conditions of the Purchase Agreement; provided, however, that for avoidance of doubt, (a) Assignor makes no representations or warranties with respect to the Trademarks, and (b) in no event shall Assignor have any indemnification obligation under the Purchase Agreement or hereunder.

4. Binding Provisions. This Assignment is binding upon, and inures to the benefit of, the parties hereto and their respective heirs, executors, legal representatives, successors, and permitted assigns.


5. Governing Law. This Agreement shall be governed by and construed in accordance with the internal laws of the State of New York, without giving effect to any choice of law provision or rule (whether of the State of New York or any other jurisdiction) that would cause the application of laws other than those of the State of New York.
