**RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS ("Release"), effective as of this _____ day of November, 2012, is made by LONE STAR BANK, S.S.B., a Texas State Savings Bank ("Lender"), with principal offices located at 100 S. Main Street, Moulton, Texas 77975, in favor of ADAMS EXTRACT & SPICE, LLC, a Texas limited liability company ("Pledgor"), with principal offices located at 3217 Johnson Road, Gonzales, Texas 78629:

WITNESSETH

WHEREAS, Lender and Pledgor have previously entered into that certain Trademark Pledge Agreement, dated as of September 16, 2005 ("Pledge Agreement"), pursuant to which Pledgor granted to the Lender a security interest in the trademarks listed on Schedule A attached hereto (collectively the "Trademarks") to secure the Obligations (as defined in the Pledge Agreement;

WHEREAS, the Obligations have been satisfied in full and Lender desires to (i) release and restore all right, title and interest in and to the Trademarks to Pledgor, (ii) to dissolve any and all liens and encumbrances respecting the Trademarks, and (iii) acknowledge that neither Pledgor nor Lender have any continuing obligations under the Pledge Agreement.

AGREEMENT

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged and accepted,

1. **Release of Security Interest.** Lender hereby releases, discharges, terminates and relinquishes unto Pledgor all continuing security interests in Pledgor's right, title and interest in, to and under the Trademarks, which security interest was duly recorded on September 28, 2005 at Reel 003209, Frame 0171 in the United States Patent and Trademark Office.

2. **Termination of Pledge Agreement.** Upon execution of this Release by Lender, neither Pledgor nor Lender shall have any continuing obligations under the Pledge Agreement, and such Pledge Agreement shall be deemed terminated and of no further force or effect.

3. **Miscellaneous.** This Release shall be governed in all respects by the laws of the State of Texas without regard to conflicts of laws principles. This Release may be executed in any number of counterparts, each of which shall be an original, but all of which together shall constitute one instrument.
