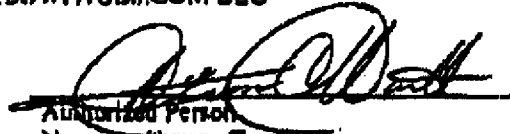

Pursuant to Section 103(d) of the General Corporation Law of the State of Delaware, the effective time of this Certificate of Merger, and the time when the merger therein provided for shall become effective shall be when this Certificate of Merger is filed with the office of the Secretary of State of Delaware.
