and the Company hereby acknowledges and confirms the purchase of the SLABB IP by the undersigned.

- (2) The undersigned shall be solely responsible for securing and recovering, at its own cost and expense, the above-stated SLABB IP and shall not seek any reimbursement or indemnification from the Company with respect thereto.
- (3) Effective upon the full execution of this letter, the undersigned expressly waives, and agrees to never assert, any claim against the Company with respect to the SLABB IP, whether based upon contract, tort, breach of duty, or other legal or equitable theory.
