**CERTIFICATE OF AMENDMENT OF
CERTIFICATE OF INCORPORATION OF
LOCUS DEVELOPMENT, INC.**

Locus Development, Inc., a corporation organized and existing under the General Corporation Law of the State of Delaware (the "**Corporation**"), hereby certifies as follows:

1. The original Certificate of Incorporation of the Corporation was filed with the Secretary of State of Delaware on January 13, 2010, under the name Locus Development, Inc. The Corporation filed an Amended and Restated Certificate of Incorporation with the Secretary of State of the State of Delaware on September 2, 2010, a Second Amended and Restated Certificate of Incorporation with the Secretary of State of the State of Delaware on March 15, 2011, and a Third Amended and Restated Certificate of Incorporation with the Secretary of State of the State of Delaware on August 8, 2012.

2. This amendment to the Certificate of Incorporation of the Corporation as set forth below has been duly adopted in accordance with the provisions of Sections 228 and 242 of the General Corporation Law of the State of Delaware by the stockholders and directors of the Corporation.

3. ARTICLE FIRST of the Certificate of Incorporation as presently in effect is amended to read in its entirety as follows:

"The name of this corporation is InVitaec Corporation (the "**Corporation**")."

4. All other provisions of the Certificate of Incorporation remain in full force and effect.
