## TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT ("Agreement") is made and entered into as of the 1<sup>st</sup> day of November, 2012, by and among KBG, LLC, a New York limited liability company ("KBG") and Atsco Footwear, LLC, a Massachusetts limited liability company ("Atsco"). KBG and Atsco are sometimes hereinafter collectively referred to as the "Parties" or each of them is sometimes referred to individually as a "Party."

WHEREAS, pursuant to a separate Asset Purchase Agreement between the Parties, KBG has agreed to purchase certain intellectual property assets from Atsco;

WHEREAS, the intellectual property assets include trademark rights which are owned by Atsco and are set forth in the attached Exhibit A (the "Trademarks"); and


WHEREAS, KBG will be the successor to the business of Atsco with which the Trademarks will be used.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Atsco does hereby irrevocably and perpetually assign, sell, transfer, convey and grant to KBG, its successors and assigns, any and all right, title and interest in and to the Trademarks, including the registrations or applications therefore, any common law rights associated therewith, the goodwill appurtenant thereto and symbolized thereby, and the right to recover for past infringements thereof, the same to be held and enjoyed by KBG, its successors and assigns to the same extent that it would have been held and enjoyed by Atsco if this Agreement had not been made.

Atsco represents, warrants and covenants that: (i) Atsco is the sole legal and equitable owner of all right, title and interest in and to the Trademarks and has full right, power and authority to enter into this Agreement and to convey the Trademarks to KBG free and clear of all liens; (ii) the Trademarks are valid, subsisting, and in full force and effect; (iii) Atsco has never granted and will not in the future grant any rights to any third parties concerning the Trademarks; (iv) the Trademark are fully assignable by Atsco to any person or entity, without payment to or consent of any other person or entity, or other condition or restriction; (v) there are no outstanding licenses, sublicenses or permissions granted by Atsco (or its designees, predecessors or affiliates) to use the Trademarks; (vi) no other entity has the right to use or register the Trademarks; and (vii) at the time of this Agreement, no third-party has asserted that the Trademarks have been abandoned or that the use of the Trademarks is unlawful or violates any party's rights.

Atsco agrees to execute and deliver to KBG, or its successors and assigns, any further documents or instruments and do any and all further acts that may be deemed necessary by KBG, or its successors and assigns, to perfect the title herein conveyed, or intended so to be, and to enable such title to be recorded with any administrative or governmental agency including without limitation, the United States Patent and Trademark Office and any similar agency in another country.
