**RELEASE OF TRADEMARK COLLATERAL ASSIGNMENT AND
SECURITY AGREEMENT**

WHEREAS, pursuant to that certain Trademark Collateral Assignment and Security Agreement, dated as of October 15, 2010 (the "Trademark Security Agreement"), recorded in the United States Patent and Trademark Office at Reel 4302, Frame 0030 on October 18, 2010, ARLON LLC (F/K/A ARLON, INC.), a Delaware limited liability company ("Releasee"), granted to ABLECO, L.L.C., a Delaware limited liability company ("Releasor"), as agent for certain lenders, a continuing security interest in and a general lien upon, and collaterally assigned and transferred to Releasor: (i) all of Releasee's then-existing or thereafter acquired right, title and interest in and to all of Releasee's trademarks, trade names, tradestyles and service marks; all prints and labels on which said trademarks, trade names, tradestyles and service marks appear, have appeared or will appear, and all designs and general intangibles of a like nature; all applications, registrations and recordings relating to the foregoing in the United States Patent and Trademark Office or in any similar office or agency of the United States, any State thereof, any political subdivision thereof or in any other countries, and all reissues, extensions and renewals thereof including, without limitation, those trademarks, service marks, terms, designs and applications described on Schedule I hereto (the "Trademarks"); (ii) the goodwill of the business symbolized by each of the Trademarks, including, without limitation, all customer lists and other records relating to the distribution of products or services bearing the Trademarks; and (iii) any and all proceeds of any of the foregoing, including, without limitation, any claims by Releasee against third parties for infringement of the Trademarks or any licenses with respect thereto (collectively, the "Collateral"); and

WHEREAS, Releasee has requested and Releasor has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its continuing security interest in and general lien upon the Collateral and the assignment and transfer to Releasee of all of Releasor's rights in and to the Collateral.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Releasor hereby, without any representation and warrant and without any recourse to Releasor, releases, relinquishes and discharges its continuing security interest in and general lien upon the Collateral and assigns and transfers to Releasee all of Releasor's rights in and to the Collateral.
