WHEREAS, Assignor is the owner of certain trademarks identified in Schedule A attached hereto, hereinafter referred to as the *Trademarks*.


WHEREAS, Assignee desires to obtain, and Assignor agrees to assign, all right, title, and interest in and to the Trademarks to Assignee;
