RELEASE OF SECURITY INTEREST IN TRADEMARKS

November 15, 2012

WHEREAS, each of SMART & FINAL STORES LLC (for itself and as successor by merger to S&F Stores Merger Sub LLC), a Delaware limited liability company, CASH & CARRY STORES LLC, an Oregon limited liability company (individually, a “**Grantor**”, and collectively, the “**Grantors**”), among others, granted a security interest (the “**Security Interest**”) in and lien upon certain trademarks and related rights to **BANK OF AMERICA, N.A.**, as collateral agent (“**Secured Party**”), as set forth in (i) that certain ABL Trademark Security Agreement dated as of May 31, 2007, by certain of the Grantors in favor of Secured Party (the “**Original Trademark Security Agreement**”), which was recorded in the United States Patent and Trademark Office on June 18, 2007 at Reel 3563, Frame 0237, (ii) that certain Supplement No. 2 to ABL Trademark Security Agreement dated as of January 29, 2010 by the Grantors in favor of Secured Party (the “**Supplement No. 2**”), which was recorded in the United States Patent and Trademark Office on February 8, 2010 at Reel 4154, Frame 0946, and (iii) that certain Supplement No. 3 to ABL Trademark Security Agreement dated as of June 29, 2011 by the Grantors in favor of Secured Party (the “**Supplement No. 3**”, and together with the Original Trademark Security Agreement and the Supplement No. 2, collectively, the “**Trademark Security Agreement**”), which was recorded in the United States Patent and Trademark Office on August 2, 2011 at Reel 4595, Frame 0959;

WHEREAS, the indebtedness secured by the Security Interest has been paid in full, and the Grantors have requested that Secured Party release and reassign to Grantors their interest in the trademarks identified in Schedule I annexed hereto and made a part hereof; and

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Secured Party hereby:


1. releases and reassigns to the Grantors any and all liens, security interests, right, title and interest of Secured Party pursuant to the Trademark Security Agreement in the trademarks identified in Schedule I and/or any goodwill associated with any of the trademarks identified in Schedule I, without recourse or representation or warranty, express or implied, of any kind;
2. agrees that any power of attorney or similar rights granted by the Grantors to Secured Party with respect to the trademarks identified in Schedule I pursuant to or in connection with the Trademark Security Agreement is terminated; and
3. authorizes and requests that the United States Patent and Trademark Office note and record the existence of the release hereby given.
