Release of Security Interest in Trademarks

October 30, 2012

WHEREAS, Kronos Incorporated, certain of its subsidiaries and Credit Suisse AG, Cayman Islands Branch (“**Credit Suisse**”), in its capacity as Collateral Agent for the Secured Parties (as each term is defined in the First Lien Security Agreement (as defined below)), entered into that certain First Lien Security Agreement dated as of June 11, 2007 (as amended, supplemented or otherwise modified from time to time, the “**First Lien Security Agreement**”);

WHEREAS, pursuant to the First Lien Security Agreement, Credit Suisse, Kronos Technology Systems Limited Partnership and Kronos Talent Management Inc. (the “**Grantors**”) entered into that certain First Lien Intellectual Property Security Agreement dated March 22, 2012 and recorded with the United States Patent and Trademark Office on April 11, 2012 on Reel No. 4773, Frame 0877 (the “**First Lien IP Security Agreement**”);

WHEREAS, under the First Lien IP Security Agreement, the Grantors granted to Credit Suisse a security interest in certain Collateral (as defined in the First Lien IP Security Agreement), including those items set forth on Schedule 1 hereto (the “**Released Collateral**”); and


WHEREAS, Credit Suisse desires to release the security interest granted by the Grantors under the First Lien IP Security Agreement in the Released Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Credit Suisse, as Collateral Agent for the Secured Parties, does hereby unconditionally, irrevocably and absolutely terminate, release, extinguish and forever discharge the security interest granted under the First Lien IP Security Agreement in the Released Collateral, together with all of the goodwill of the business connected with the use of, or symbolized by, such Released Collateral, and hereby unconditionally, irrevocably and absolutely assigns, transfers and conveys to the Grantors all right, title and interest of Credit Suisse in, to and under such Released Collateral and such goodwill granted under the First Lien IP Security Agreement. This Release of Security Interest in Trademarks shall be binding upon Credit Suisse’s legal representatives, assigns and successors and upon the Secured Parties. Credit Suisse also hereby authorizes, and requests, the Director of the United States Patent and Trademark Office or his delegate to record this Release of Security Interest in Trademarks against the Released Collateral.

IN WITNESS WHEREOF, Credit Suisse has caused this Release of Security Interest in Trademarks to be duly executed by its officer thereunto duly authorized as of the day and year first above written.
