**GRANT OF SECURITY INTEREST IN TRADEMARKS**

This GRANT OF SECURITY INTEREST IN TRADEMARKS (the "Grant"), dated as of October 25, 2012, made by Corsair Artisan LLC, a Tennessee limited liability company ("Grantor"), in favor of Mountain Crest Srl d/b/a Minhas Craft Brewery, a Barbados corporation ("Secured Party").

WHEREAS, Grantor is the owner of the United States trademarks set forth in Reg. No. 3,976,480 CORSAIRS ORANGE SQUEEZE, Reg. No. 3,976,481, CORSAIRS ORANGE SQUEEZE and Design and Application Serial No. 85/460,881 CORSAIRS (collectively, the "Trademarks") and all goodwill of any business associated and connected therewith or symbolized thereby; and

WHEREAS, pursuant to the Agreement effective October 25, 2012, by and among Grantor and Secured Party (the "Agreement"), Grantor granted, assigned and conveyed to Secured Party a continuing security interest in, and lien on the Trademarks; and

WHEREAS, pursuant to the Agreement, Grantor agreed to execute and deliver to Secured Party this Grant for purposes of filing the same with the United States Patent and Trademark Office (the "PTO") to confirm, evidence and perfect the security interest in the Trademarks granted pursuant to the Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and subject to all applicable terms and conditions of the Agreement, which are incorporated by reference as if fully set forth herein, Grantor hereby grants, assigns and conveys to Secured Party a continuing security interest in, and lien on, the Trademarks.

1. The parties intend that this Grant is for recordation purposes only and its terms shall not modify the applicable terms and conditions of the Agreement. Grantor hereby acknowledges the sufficiency and completeness of this Grant to create the security interest in the Trademarks, and Grantor hereby requests the PTO to file and record the same.
