

NOTICE OF RELEASE OF
SECURITY INTEREST IN TRADEMARKS

WHEREAS, pursuant to that certain Trademark Collateral Agreement, dated as of June 20, 2011 (the "Trademark Collateral Agreement"), by Jimmy Sanders, Inc. ("Grantor") in favor of Regions Bank, as Collateral Agent (the "Collateral Agent"), recorded in the United States Patent and Trademark Office at Reel 4570, Frame 0542, the Grantor assigned and granted to the Collateral Agent a security interest in Grantor's right, title and interest in and to the trademarks listed on Exhibit A hereto (the "Released Assets"); and



3. Governing Law. This Notice of Release of Security Interest in Trademarks shall be governed by and construed and interpreted in accordance with the laws of the State of New York.
4. Definitions. Capitalized terms used herein and not defined shall have the respective meaning ascribed to such terms in the Trademark Collateral Agreement.
