DISCHARGE OF RECORDED SECURITY INTEREST

WHEREAS, by an Intellectual Property Security Agreement (the "Security Agreement") dated November 15, 2010 (the "Security Agreement"), Balance Bar Company ("Balance Bar") granted a security interest in the United States trademarks listed in Exhibit A attached hereto and certain other collateral (the "Collateral") to HSBC Mezzanine Partners USA, L.P., as Administrative Agent and Collateral Agent for certain Secured Parties (hereinafter referred to as the "Agent"), in order to secure repayment of certain amounts owing to such Secured Parties (the "Indebtedness").

NOW THEREFORE, to all who it may concern be it known that for and in consideration of the payment to the Agent of the full amount of the Indebtedness, the Agent hereby (a) releases and discharges all the security interests granted by the Security Agreement, being the security interests granted in respect of the Collateral and (b) acknowledges, confirms and agrees that the Security Agreement is discharged, released and terminated and of no further force or effect.
