PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARKS, (this "Partial Release") is made as of November 15, 2012 ("Effective Date") by GENERAL ELECTRIC CAPITAL CORPORATION, in its capacity as Lender ("Grantee"), in favor of ARGON MEDICAL DEVICES, INC. ("Grantor").

WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement, dated as of September 30, 2010 (the "Trademark Security Agreement") and pursuant to that certain Credit Agreement, dated as of September 30, 2010, Grantor mortgaged, pledged, and hypothecated, and granted to Grantee, a Lien (as defined in the Trademark Security Agreement) on and a security interest in all of its right title and interest to, in and under the Trademark Collateral (as defined in the Trademark Security Agreement), including the trademark registration set forth on Schedule 1 attached hereto together with (i) all renewals and extensions thereof, (ii) all income, royalties, proceeds and liabilities at any time due or payable or asserted under and with respect thereto and (iii) the goodwill associated therewith ("Specified Collateral");

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office ("USPTO") on September 30, 2010 at Reel 4287, Frame 0333.

WHEREAS, Grantee desires to terminate, cancel and release any and all security interests it holds in the Specified Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby covenants and agrees as follows:

Grantee hereby absolutely, unconditionally and irrevocably terminates, cancels releases any and all mortgage interests, pledges, hypothecation, Liens, or security interests in, upon or against the Specified Collateral and reassigns and transfers any right, title and interest that the Grantee may have in the Specified Collateral to the Grantor.

Nothing herein is, or shall be deemed, a termination, cancellation, release or other modification of the Grantee's security interests or liens on any other Trademark Collateral.
