REACH Call, Inc., organized and existing under and by virtue of the Georgia Business Corporation Code,

**DOES HEREBY CERTIFY:**

1. That the name of this corporation is REACH Call, Inc., and that this corporation was originally incorporated pursuant to the Georgia Business Corporation Code on March 14, 2006 under the name REACHMDCONSULT, INC.

2. The Board of Directors of the Corporation has duly adopted the following resolution on December 10, 2010, setting forth an Amended and Restated Articles of Incorporation of the Corporation and has recommended that the stockholders of the Corporation approve said amendments and restatements. The stockholders have duly approved the Amended and Restated Articles of Incorporation at a special meeting on December 20, 2010 pursuant to Section 14-2-1003 of the Georgia Business Corporation Code.

**RESOLVED**, that the Articles of Incorporation of this Corporation be amended and restated in its entirety to read as follows:

**FIRST:** The name of this corporation is REACH Health, Inc. (the "Corporation").

**SECOND:** The address of the registered office of the Corporation in the State of Georgia is 14725 Westside Way, Suite 350, Alpharetta, Georgia 30009. The name of its registered agent at such address is Kenneth D. Rardin.

**THIRD:** The nature of the business of, or purposes to be conducted or promoted by, the Corporation is to engage in any lawful act or activity for which corporations may be organized under the Georgia Business Corporation Code (the "GBCC").

**FOURTH:** The total number of shares of all classes of stock which the Corporation shall have authority to issue is Thirteen Million Nine Hundred Thirteen Thousand Five Hundred Thirty-Six (13,913,536) shares, consisting of: (i) Ten Million (10,000,000) shares of Common Stock, no par value per share (the "Common Stock"), and Three Million Nine Hundred Thirteen Thousand Five Hundred Thirty-Six (3,913,536) shares of Preferred Stock, no par value per share (the "Preferred Stock").

The following is a statement of the designations and the powers, preferences and rights and the qualifications, limitations or restrictions of the capital stock of the Corporation.
