**NOTICE OF RELEASE
OF SECURITY INTEREST IN U.S. TRADEMARKS**

This **NOTICE OF RELEASE OF SECURITY INTEREST IN U.S. TRADEMARKS** ("Notice of Release"), effective as of November 20, 2012, is made by **BANK OF AMERICA, N.A.**, as Collateral Agent (the "Collateral Agent").

WHEREAS, **TRACKER MARINE, L.L.C.**, a Missouri limited liability company, **BASS PRO INTELLECTUAL PROPERTY, L.L.C.**, a Missouri limited liability company, **OUT O'SITE, LLC**, a Missouri limited liability company, **BIG CEDAR, L.L.C.**, a Missouri limited liability company, **ISLAMORADA FISH COMPANY, LLC**, a Missouri limited liability company, and **MAKO MARINE INTERNATIONAL, LLC**, a Delaware limited liability company (each a "Grantor", and collectively, the "Grantors"), and JPMorgan Chase Bank, N.A., as administrative agent and collateral agent ("JPMorgan"), entered into that certain Pledge and Security Agreement dated as of April 12, 2010 (the "Security Agreement"), whereby each Grantor granted to JPMorgan a continuing security interest (the "Security Interest") in all of its right, title and interest in the Trademark Collateral (as defined in the Security Agreement), including, without limitation, each trademark registration and application listed on Schedule I attached hereto and incorporated herein by reference (the "Specified Trademark Collateral").
