**TERMINATION AND RELEASE OF  
INTELLECTUAL PROPERTY SECURITY AGREEMENT**  
**(under Second Lien Credit Agreement)**

**Whereas**, Esquire Deposition Solutions, LLC, formerly known as Bayside Gallo Acquisition, LLC ("Borrower") and Bayside Gallo Recovery, LLC ("Agent") executed an Intellectual Property Security Agreement dated November 23, 2011 ("Security Agreement"); and

**Whereas**, the Security Agreement was entered into pursuant to a Second Lien Credit Agreement dated November 23, 2011 ("Credit Agreement") by and between Borrower, certain lenders as named therein ("Lenders"), and Agent as administrative agent for the Lenders; and

**Whereas**, pursuant to the Security Agreement, Borrower granted to Agent, for the benefit of itself and the Lenders, a security interest in, among other assets, the registered trademarks listed on Exhibit A hereto ("the Marks"); and

**Whereas**, all obligations of Borrower secured by the Security Agreement were fully released and discharged as of no later than June 1, 2012 ("the Effective Date"); and

**Whereas**, Agent, for the benefit of itself and the Lenders, has agreed to terminate and release its security interest and all right, title and interest in each of the Marks, and acknowledges that such termination is appropriate pursuant to Section 13 of the Security Agreement;

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, it is agreed as follows:

- 1. Release and Assignment.** Agent, for the benefit of itself and the Lenders, hereby terminates and releases its security interest in and first priority lien on all of the Marks, and hereby assigns and transfers to Borrower, without recourse, all right, title and interest in and to each of the Marks, including all registrations thereof in any jurisdiction and all related goodwill, effective as of the Effective Date.
- 2. Acknowledgment and Acceptance.** Borrower hereby acknowledges and accepts the foregoing release and assignment by Agent, for the benefit of itself and the Lenders.
- 3. Governing Law.** This Release shall be construed in accordance with, and this Release and all matters arising out of or relating in any way whatsoever (whether in contract, tort or otherwise) to this Release shall be governed by, the law of the State of New York.
- 4. Counterparts.** This Release may be executed in any number of counterparts which shall together constitute one and the same agreement. Transmission of electronic images of signed counterparts shall have the same effect as delivery of signed paper originals.

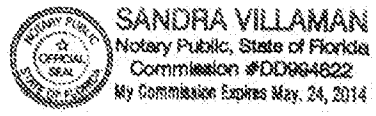
