Pursuant to the provisions of the Texas Business Corporation Act, Article 5.17 et seq., the undersigned corporation hereby adopts the following Articles of Conversion for the purpose of converting LJM Products, Inc., a Texas Corporation (the "Converting Entity"), to a Texas limited partnership to be known as "LJM Products, LP" (the "Converted Entity"). In this regard, the undersigned officer of the Converting Entity hereby certifies the following:

1. The Converting Entity is LJM Products, Inc., a Texas corporation.
2. A Plan of Conversion has been approved by the directors and the shareholders of the Converting Entity.
3. The executed Plan of Conversion is on file at the principal place of business of the Converting Entity, 10315-A Metropolitan, Austin, Texas 78758, and an executed Plan of Conversion will be on file, from and after the conversion, at the principal place of business of the Converted Entity, 10315-A Metropolitan, Austin, Texas 78758.
4. A copy of the Plan of Conversion will be furnished by the Converting Entity (prior to the conversion) or the Converted Entity (after the conversion), on written request and without cost, to any shareholder of the Converting Entity or partner of the Converted Entity.
5. The number of shares of the Converting Entity outstanding is 80,000 shares of common stock. All shares are of the same class and series.
6. The number of outstanding shares that voted for the plan is 80,000 and the number of shares that voted against the plan is none.
7. In lieu of the Comptroller's certificate, the Converted Entity will be responsible for the payment of all fees and franchise taxes.

8. The conversion will become effective on the later of February 28, 2002 at 11:59 p.m., Austin, Texas time or the date and time of the filing of these Articles of Conversion in accordance with the provisions of the Texas Business Corporation Act.
