NUNC PRO TUNC TRADEMARK ASSIGNMENT

WHEREAS, ASSIGNOR has certain tangible and intangible assets associated with the Trademark Registration, including but not limited to, business plans, contact information, data and other information of business value that it also hereby assigns to ASSIGNEE;

WHEREAS, ASSIGNEE desired to acquire all rights, title, and interest in and to the Trademarks and the Trademark Registration and any other registered or unregistered trademarks owned or used by ASSIGNOR or any of its licensees;

WHEREAS, ASSIGNOR was willing to assign to ASSIGNEE all rights, title, and interest as ASSIGNOR may possess in and to the Trademarks and Trademark Registration along with the goodwill and business associated therewith; and

WHERE, ASSIGNOR did assign to ASSIGNEE, as of the effective date of this Trademark Assignment, all rights, title, and interest as ASSIGNOR did possess in and to the Trademarks and Trademark Registration worldwide, together with the goodwill and business associated therewith;


