RELEASE OF FIRST LIEN INTELLECTUAL PROPERTY SECURITY AGREEMENT

THIS RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT (this "Release") is made as of November 8, 2012 (the "Effective Date") by JPMorgan Chase Bank, N.A., as collateral agent (in such capacity, the "Agent"), in favor of Pot- ters Industries, LLC (the "Borrower") and each of the grantor parties identified on the signature page hereto (each, together with the Borrower, the "Grantors").

WHEREAS, pursuant to the terms and conditions of that certain First Lien Security Agreement, dated as of May 6, 2011, between the grantors party thereto and the Agent, and the Intellectual Property Security Agreement between the grantors party thereto and the Agent, dated as of May 6, 2011 (the "IP Security Agreement"), each of the Grantors pledged, assigned and granted to the Agent a continuing security interest in all of its right, title and interest in and to certain collateral including, without limitation, (a) the trademark registrations and applications set forth on Schedule I hereto, along with the goodwill associated therewith (collectively, the "Trademarks"), (b) the patents and patent applications set forth on Schedule II hereto (collective- ly, the "Patents") and (c) all copyrights, whether registered or unregistered, now owned or here- after acquired by such Grantor, including, without limitation, the copyright registrations set forth in Schedule III hereto and exclusive copyright licenses (collectively, the "Copyrights");

WHEREAS, the IP Security Agreement was recorded with the Trademark Divi- sion of the U.S. Patent & Trademark Office on May 13, 2011 at Reel 004541 and Frame 0236;

WHEREAS, the IP Security Agreement was recorded with the Patents Division of the U.S. Patent & Trademark Office on May 13, 2011, at Reel 026273 and Frame 0740;

WHEREAS, the IP Security Agreement was recorded with U.S. Copyright Office on May 16, 2011, at Volume 3596 and Document 90;

NOW, THEREFORE, for good and valuable consideration, the receipt and suf- ficiency of which are hereby acknowledged, the Agent hereby, without any warranty or recourse of any kind, terminates the Security Agreement, and hereby terminates, cancels, re-pledges, reas- signs and releases any and all security interests it has against the Trademarks, the Patents and the Copyrights.

If and to the extent the Agent has acquired any right, title or interest to any of the Trademarks, the Patents or the Copyrights, it hereby re-assigns and re-transfers such rights, title or interest to their respective Grantors.

The Agent shall take all further actions, and provide to the Grantors and their suc- cessors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantors, at the Grantors' sole cost and expense, to more fully and effectively effectuate the purposes of this Release.
