**RELEASE OF SECURITY INTEREST IN
INTELLECTUAL PROPERTY COLLATERAL**

This RELEASE, dated as of November 26, 2012, is made by UBS AG, STAMFORD BRANCH, in its capacity as Collateral Agent (the "Collateral Agent") pursuant to the Security Agreement (Second Lien), dated as of December 7, 2006 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement") among JW Aluminum company, a Delaware corporation (the "Pledgor"), JW Aluminum Holding Corp., a Delaware corporation, and Collateral Agent. Capitalized terms used herein not otherwise defined herein shall have the meanings ascribed thereto in the Security Agreement.

WITNESSETH

WHEREAS, the Pledgor and the Collateral Agent are parties to the Security Agreement;

WHEREAS, pursuant to the Security Agreement, the Pledgor executed the Patent Security Agreement (Second Lien) dated December 7, 2006 and recorded with the U.S. Patent and Trademark Office on March 12, 2007 at Reel/Frame No. 018989/0750, pursuant to which the Pledgor granted to the Collateral Agent a lien on and security interest in and to all of its right, title and interest in, to and under all the following Pledged Collateral of such Pledgor (a) Patents of the Pledgor listed on Schedule I attached hereto; and (b) all Proceeds of any and all of the foregoing (other than Excluded Property) (the "Patent Collateral");

WHEREAS, pursuant to the Security Agreement, the Pledgor executed the Trademark Security Agreement (Second Lien) dated December 7, 2006 and recorded with the U.S. Patent and Trademark Office on March 12, 2007 at Reel/Frame No. 3497/0764, pursuant to which the Pledgor granted to the Collateral Agent a lien on and security interest in and to all of its right, title and interest in, to and under all the following Pledged Collateral of such Pledgor (a) Trademarks of the Pledgor listed on Schedule I attached hereto; (b) all Goodwill associated with such Trademarks; and (c) all Proceeds of any and all of the foregoing (other than Excluded Property) (the "Trademark Collateral");


WHEREAS, the Pledgor has requested that the Collateral Agent release its lien on and security interest in and to all of its right, title and interest in and to the Patent Collateral and the Trademark Collateral.


