## TRADEMARK ASSIGNMENT

This Trademark Assignment (hereinafter referred to as "Assignment") is effective as of July 20, 2012, by and between Mini Movie International Channel SARL, a company created and existing under the laws of Luxembourg, having a place of business at No. 15 Rue du Fort Bourbon, Luxembourg L-1249 Grand-Duché de Luxembourg, (hereinafter referred to as "ASSIGNOR") and George S. Taweel, Inc., a corporation duly organized under the laws of the State of New Jersey, whose address is 4024 Radford Avenue, Studio City, California 91604, (hereinafter referred to as "ASSIGNEE").

WHEREAS, ASSIGNOR has obtained registration in the Principal Register of the United States Patent and Trademark Office, Registration Number 3,614,341, for the mark MINIMOVIE (hereinafter "MARK"), for which an application was filed on March 27, 2007 in the International Class 38 for streaming of video material on the internet with a first use anywhere date of at least as early as July 3, 1996, and has used and is continuing to use said Mark in connection with such services in the United States;


WHEREAS, ASSIGNOR and ASSIGNEE have entered into an agreement ("Agreement") pursuant to which ASSIGNOR agreed to assign that certain portion of its ongoing and existing business in the United States to which the MARK pertains, the MARK, the goodwill and business symbolized thereby, and the aforementioned trademark registration therefore; and

WHEREAS, ASSIGNOR pursuant to the Agreement is hereby assigning to ASSIGNEE the MARK along with the goodwill and business symbolized thereby and the aforementioned trademark registration therefore and transfers to ASSIGNEE the portion of its business in the United States to which the MARK pertains.

NOW THEREFOR, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR does hereby assign to ASSIGNEE all rights, title and interest in and to said MARK and said registration of said MARK, together with the goodwill of the business symbolized by the MARK. ASSIGNOR also transfers to ASSIGNEE the right to recover for past infringement of the MARK.
