**CERTIFICATE OF AMENDMENT TO
THE ARTICLES OF INCORPORATION OF
EMPLOYEE BENEFIT SOLUTIONS, INC.**

The undersigned corporation (the "Corporation") hereby duly executes this Certificate of Amendment to the Articles of Incorporation now known as Certificate of Formation, which is being filed with the Secretary of State under the Texas Business Organizations Code (the "Code").

1. The name of the Corporation is Employee Benefit Solutions, Inc. The Corporation is a Texas corporation.
2. The file number issued to the Corporation by the Secretary of State is 137627500.
3. The date of formation of the Corporation is November 7, 1995.

Amended Name

The amendment changes the Articles of Incorporation to change the article that names the Corporation. The article is amended to read as follows:

The new name of the Corporation is Ascende, Inc.

The Certificate of Amendment to the Articles of Incorporation has been approved in the manner required by the Code and by the governing documents of the Corporation.

This document becomes effective at a later date, which is not more than ninety (90) days from the date of signing. The delayed effective date is October 30, 2012.

The undersigned signs this document subject to the penalties imposed by law for the submission of a materially false or fraudulent instrument and certifies under penalty of perjury that the undersigned is authorized under the provisions of law governing the Corporation to execute the filing instrument.
