TRADEMARK ASSIGNMENT, effective as of September 20, 2012 (the "Effective Date") by **Garmont NA, Inc.**, a Vermont corporation with its principal place of business at 308 NW 11th Ave., Suite 200, Portland, OR 97209 (formerly 170 Boyer Circle, Williston, Vermont 05495) ("Assignor"), in favor of **Scott USA, Inc.**, a Delaware corporation, PO Box 2030, Sun Valley, ID 83353 ("Assignee").

WHEREAS, pursuant to that certain Asset Purchase Agreement dated September 20, 2012, as amended, between Assignor and Assignee (the "Purchase Agreement"), Assignor has agreed to assign to Assignee its entire right, title and interest in and to the trademarks and trademark registration set forth below (the "Mark"), and the goodwill of the business associated with the Mark:

NOW THEREFORE, for good and valuable consideration paid by Assignee to Assignor, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns to Assignee Assignor's entire right, title and interest in and to the Mark together with the goodwill of the business associated with the Mark, including all registrations and applications therefor, as well as all renewals and extensions of registrations that are or may be secured by Assignee, its successors, assigns or other legal representatives, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by the Assignor if this assignment and sale had not been made, together with all income, royalties, damages or payments due or payable as of the Effective Date or thereafter including, without limitation, all claims for damages by reason of past, present and future infringement or other unauthorized use of the Mark, with the right to sue for damages and collect the same for Assignee's own use and enjoyment and for the use and enjoyment of its successors, assigns or other legal representatives. Assignor authorizes and requests the Commissioner of Patents and Trademarks of the United States, and any official of any country or countries foreign to the United States, whose duty it is to register trademarks, to record Assignee as the assignee and owner of the Mark.

Assignor hereby represents and warrants that the Mark is free and clear of any liens and encumbrances and that the Assignor has not executed and will not execute any agreement or other instrument in conflict herewith.

Assignor hereby covenants and agrees that it shall cease and refrain from all use of the Mark in all countries of the World as of the Effective Date.
