Assignor hereby sells, assigns, transfers and conveys to Assignee the entire right, title, interest in and to the Trademarks and the Property in the United States and all jurisdictions outside the United States, together with (i) the goodwill of the business connected with and symbolized by the Trademarks and Property including, without limitation, the right to renew any registrations included in the Trademarks and Property, the right to apply for trademark registrations within or outside the United States based in whole or in part upon the Trademarks, and any priority right that may arise from the Trademarks, (ii) all income, royalties and damages hereafter due or payable to Assignor with respect to the Trademarks and Property, including, without limitation, damages and payments for past or future infringements and misappropriation of the Trademarks and Property; and (iii) all rights to sue for past, present and future infringements or misappropriations of the Trademarks and Property, the same to be held and enjoyed by Assignee as fully and entirely as said interest could have been held and enjoyed by Assignor had this sale, assignment, transfer and conveyance not been made.

Assignor authorizes the Commissioner of Trademarks of the United States and other empowered officials of the United States Patent and Trademark Office and in any applicable jurisdictions outside the United States to record the transfer of the registrations and/or applications for registration set forth on Exhibit "1" to Assignee as assignee of Assignor's entire right, title and interest therein. Assignor agrees to further execute any documents reasonably necessary to effect this assignment or to confirm Assignee's ownership of the Trademarks.

This Trademark Assignment may be executed by the parties hereto in separate counterparts, each of which when so executed and delivered shall be a original, but all such counterparts taken together shall constitute one and the same instrument. Each counterpart may be delivered by facsimile transmission, which transmission shall be deemed delivery of an originally executed document.



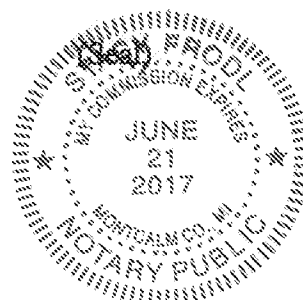
